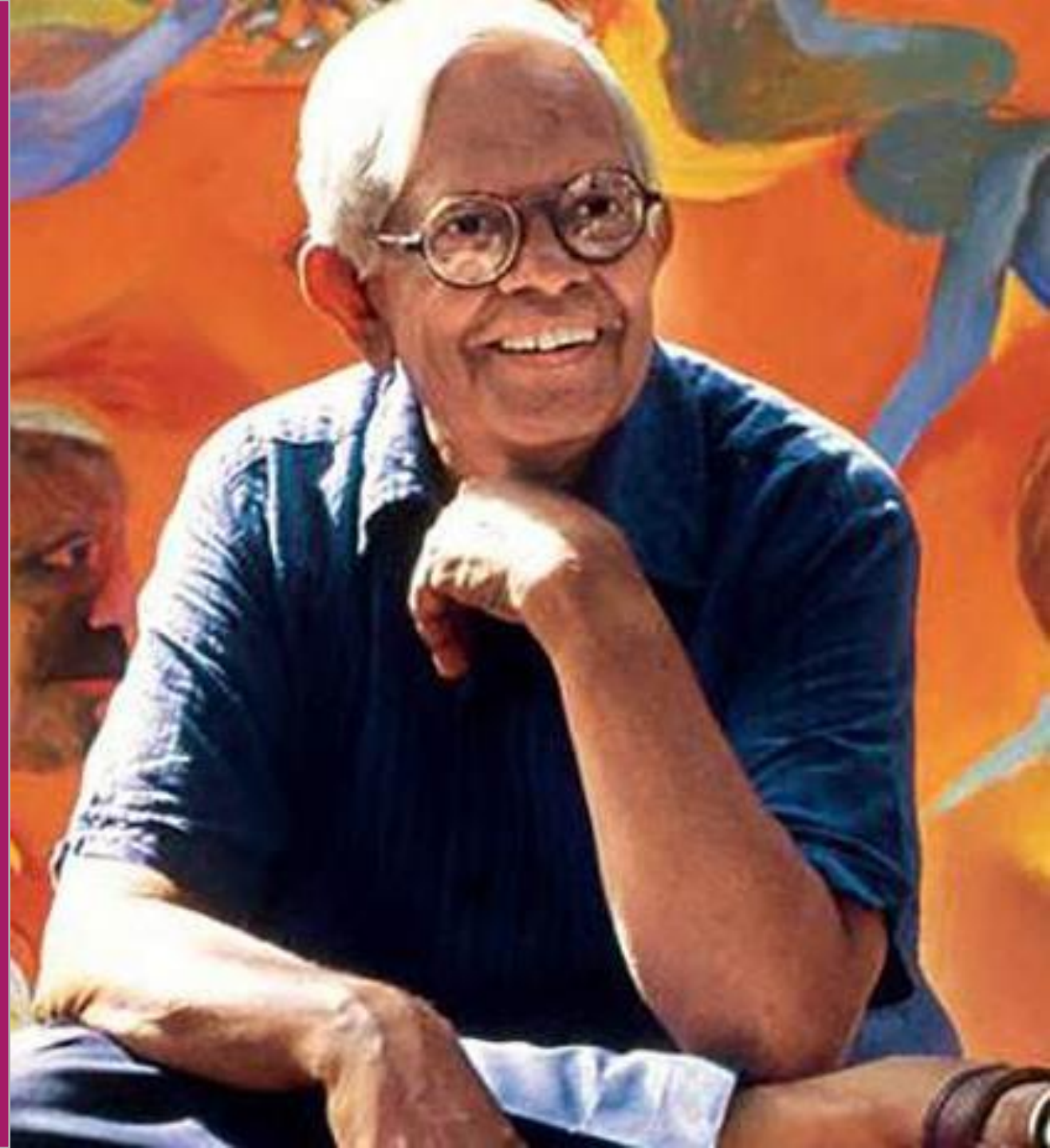

Bhupen Khakar was born in Bombay, India in 1934. He was the youngest of 4 children and their father died when Bhupen was just 4 years old.

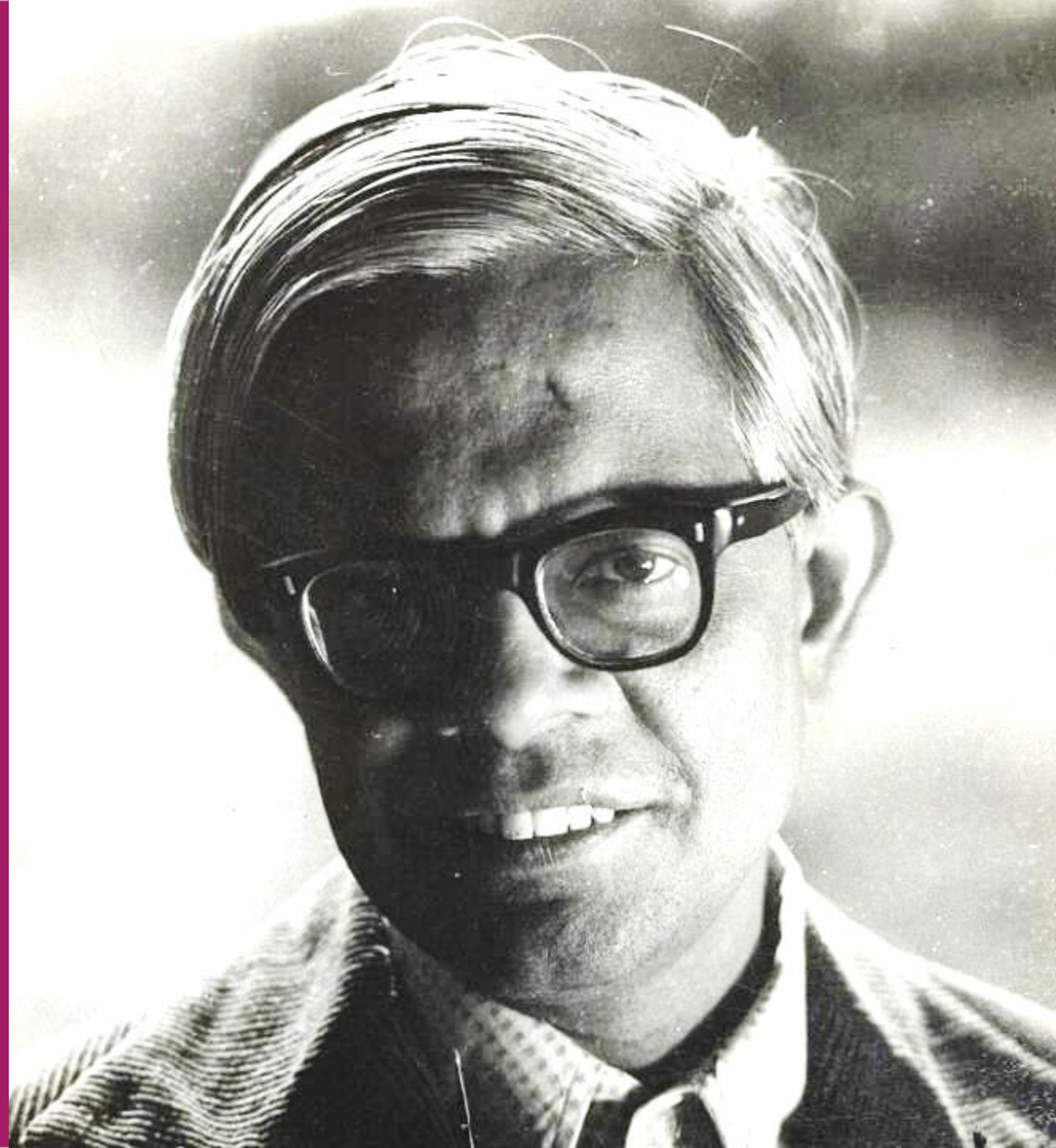
Bhupen grew up speaking Gujarati, Marathi and Hindi. He was 13 when India gained Independence from British Colonial rule.



New directions

Bhupen worked as an accountant for many years, but became an artist after a friend encouraged him.

He was a self-taught artist, but joined the Faculty of Fine arts at Baroda University in 1962.



Identity and society

Bhupen painted with oil, gouache or watercolour and his work has been compared to that of David Hockney. He also worked with ceramics and collage.

His art work showed people's day to day struggles. His work contains lots of personal references and explores his gay identity.



International travel

Bhupen's first trip abroad was in 1976 as part of a cultural exchange programme. He visited a number of countries including the UK, where he stayed with his friend Sir Howard Hodgkin.

He returned to the UK for 6 months in 1979 and worked as an artist-in-residence at the Bath Academy of Art.



Coming out

During his time in the UK, Bhupen experienced an increasing acceptance of gay people. He became friends with other LGBTQ+ artists too. Bhupen came out as gay in 1980.

After this, Bhupen spent more time exploring his gay identity through his work. He was with his partner, Vallavbhai, for over 20 years.



Overcoming prejudice

Until 2018, it was illegal to be gay in India. This is because of a law introduced by the British in 1861, whilst India was under British colonial rule.



Success and recognition

In 2000, Bhupen Khakhar was honoured with the Prince Claus Award to honour his work in the field of art. His art has been exhibited around the world, and in 2016 the Tate Modern held a retrospective of Bhupen's art entitled 'You Can't Please All'.

Bhupen died of prostate cancer in 2003, just a few days after the death of his partner.
